- 4. The deadline for receipt of your quotation(s) by the purchaser at the indicated address is 1st August 2021 before 10:00 AM to Dzongkhag Procurement Section and will be opened same day at 10.30 AM BST on 1st August 2021 in Dzongkhag Conference Hall.
- 5. The bid shall be accompanied by a bid security of Nu. 20,000/-. (Twenty Thousand) only in the form of cash warrant, demand draft or unconditional Bank Guarantee valid till one year. Any bid not accompanied by bid security shall be treated as non-responsive.
- 6. Quotation by fax or by electronic means (are not) acceptable
- 7. The quotation should be submitted as per the following instructions and in accordance with the attached Contract. The attached Terms and Conditions of Supply is an integral part of the Contract.
 - a) PRICE: all prices shall be quoted in Ngultrum. The quoted price shall be inclusive of all related costs including taxes, duties and other levies to the final place of delivery. The final place of delivery is as per the work order.
 - b) EVALUATION OF QUOTATION: offers determined to be substantially responsive to the technical specifications will be evaluated by comparison of their quoted prices. In evaluating the quotations, the purchaser will determine for each quotation the evaluated price by adjusting the priced quotation by making any correction for any arithmetical errors as follows;
 - (i) where there is a discrepancy between amounts in figures and in words, the amount in words will govern;
 - (ii) where there is discrepancy between the unit rate and the line-item total resulting from multiplying the unit rate by the quantity, the unit rate as quoted shall govern unless in the opinion of the Employer there is an obviously gross misplacement of the decimal point in the unit rate, in which case the line-item total as quoted shall govern, and the unit rate shall be corrected.
 - (iii) If the supplier refuses to accept the correction, this quotation will be rejected and the bid security shall be forfeited.

- 12. The Purchaser is not bound to accept the lowest bid and reserves the right to accept or reject any or all the bids without assigning any reason whatsoever.
- 13. The bidder whose bid is accepted will be notified of the award of contract by the Purchaser prior to expiration of the quotation validity period. The terms of the accepted offer shall be incorporated in the work order.





Documents required to be submitted as part of the Quotation

The original and copy(ies) of quotation submitted by the supplier shall comprise the following:

- (a) A duly completed and signed priced quotation as per the price schedule & unit.
- (b) Valid vehicle registration documents (Registration certificate, fitness certificate, insurance certificate).
- (c) Bid security in the form of Cash Warrant or Demand Draft from the reputed financial institution for the period for one year.

Terms and Conditions for the hiring of Vehicle.

The Terms and Conditions hereinafter may only be varied with the written agreement of the Purchaser and no terms and conditions put forward at any time by the Supplier shall form any part of the Contract.

- 1. The Supplier shall be required to submit a performance security of lump sum Nu; 20,000/-(Twenty thousand only) form of cash warrant, demand draft or unconditional Bank Guarantee issued by a financial institution located in Bhutan, which shall be furnished upon signing the contract. Performance security shall be valid till the end of warranty period and will be returned after the end of warranty period.
- 2. The hiring of vehicle shall be completed within *said* days from the date of issue of the work Order,
- 3. Payment of the Invoice shall be arranged by the Purchaser, upon submission of original Invoice and TPN number, against each performance of the activities.
- 4. The quoted price shall include all taxes, duties, insurance and any other costs involved and nothing extra shall be paid.
- 5. The supplier shall pay liquidated damages at the rate of 0.01% per day for each day of delay to a maximum of 10% of the quoted price.
- 6. The Purchaser may, by written notice, terminate the Purchase Order (or Contract if applicable) in whole or in part at any time for its convenience:

- a) If the Supplier fails to perform any other Terms and conditions specified with the Purchase Order, or exceeds the maximum amount of liquidated damages.
- b) If the Supplier fails to perform any other obligation(s) under the Purchase Order, or
- c) If the Supplier does not take any remedial action within a period of (7) seven calendar days after receipt of a notice of default from the Purchaser specifying the nature of the default(s), or
- d) If the Supplier, in the judgment of the Purchaser, has engaged in any corrupt or fraudulent practices in competing for or in executing the tasks under this Purchase Order; and
- 7. The security deposit shall be used to cover the cost of supplies defective works.
- 8. The purchaser may place work order from the open market in case the supplier fails to provide service (Transportation) within the stipulated time and realize the difference amount between the quoted price & market price from the security deposit.
- 9. The vehicle must be deputed whenever required by the Procuring Agency. The verbal and written reminders shall be given by Dzongkhag Administration on failing of any obligation by supplier. The Dzongkhag Administration will use discretion power to terminate and forfeit the performance security.
- 10. The Procuring Agency shall not entertain halt charge in any means.
- 11. The bidder must take care of road blocks, strikes and halt at quarantine besides procuring agency. The bidders will not be paid for halt charges in any cases.
- 12. The quoted rate of the bidder is applicable only as per the movement authorization approved by the Procuring Agency or with due permission from official on duty.
- 13. The quoted rate shall be inclusive of Loading and unloading charges.
- 14. The bidder (Transporter) must be responsible for any losses or misplacement of goods during the time of transit.
- 15. The bidder must be responsible and ensure the vehicle given for hire is always in good condition.
- 16. The bidder must insure that driver concern should carry all the valid licenses and document at the time of hiring period.
- 17. The driver must strictly follow covid-19 protocols during the time of transportation.
- 18. Any breach of covid-19 protocols must be liable for termination of contract with forfeiture of performance security.
